

### **Hype:** Sales tax is no big deal.


It is true that sales tax rates are generally lower than income tax rates. Amounts charged on individual sales transactions are not by themselves significant; however, across all sales, the dollars can quickly add up. When you consider the additional cost of penalties, interest and audit adjustments, there is an even greater cost for businesses that fail to properly collect, report, or remit sales tax. At a time when states are seeking to increase their revenues to cover budget shortfalls and businesses are seeking to hold on to their profits, wise business leaders can no longer afford to ignore sales tax management. States are beefing up their sales and use tax enforcement efforts when businesses can least afford an unexpected, and potentially negative, audit adjustment.



#### **Fact:** Sales taxes are complicated.

In order to properly assess, collect, and remit sales taxes, businesses need help answering the following questions for each state in which they sell:

- **1. Nexus** What activities are you performing in a given state and are they sufficient to establish a taxable connection?
- **2. Rules** Are the items or services you sell taxable in a given state? Is the buyer subject to sales tax? Are goods being purchased for resale?
- **3.** Rate What rate of tax applies to a taxable sale? Have you considered all local taxing jurisdictions and recent updates?
- **4. Jurisdiction** Which jurisdiction has the right to tax a particular sale?
- **5. Taxability** Which items are taxable in a given jurisdiction and at what rate?
- **6. Sourcing** Does a given state use a destination or origination basis for determining taxability in-state? Or does it use a combination of the two? Are you tracking well enough to ensure sales taxes are remitted to the right jurisdiction?


### Hype: It's all about the rate.

Many solutions provide automated sales and use tax rate updates on CD or via download from the web. While having the correct rate is important, this is just one aspect of sales tax management. Without help in determining nexus, applying rules and identifying taxable jurisdictions, businesses are in danger of assessing, collecting, and remitting the wrong amount of tax. Few businesses can afford to increase their audit risk or make costly mistakes on customer billing.



### **Fact:** There is only one opportunity to collect the right amount of sales tax.

If you don't collect the proper amount of tax at the time of sale, you cannot go back to your customer and request payment without endangering your relationship. Any adjustments to that initial charge (whether by audit or amendment) become business expenses that reduce your profits. Few businesses can afford to convert a pass-through tax to a business expense. 
### Hype: Just show good form.




#### Hype: It's close enough.

Zip codes are simply not granular enough for most states, as many taxable jurisdictions can share the same zip code. While these rate tables may be sufficient for retail sales made from a single location, they can lead to unnecessary errors and costly audit adjustments for anyone shipping goods to multiple locations.


# **Fact:** When it comes to sales tax, precision counts.

Tax jurisdictions can vary from house to house on the same street and within a single zip code. 
### Hype: You can do it yourself.
